QUALIFIED DRIVER AGREEMENT

By signing below, I _____ agree that I am at least 18 years of age, that I have a valid, unrestricted driver’s license, and that I have read and understand the information on this document.

- This vehicle is not equipped with most of the safety features of a regular car or truck.
- For safety reasons, this vehicle is never to be operated on any road, public or private, with a posted speed limit of more than 25 mph.
- This vehicle may only cross a road of 35 mph or less provided the crossing begins and ends on a road of 25 mph or less and is controlled by a traffic signal or four-way stop signs.
- THIS VEHICLE OFFERS MUCH LESS CRASH PROTECTION THAN A REGULAR CAR, VAN, OR TRUCK. THIS MEANS A HIGHER RISK OF INJURY OR DEATH IN COLLISIONS, EVEN AT LOW SPEEDS. The higher the speed of the traffic around you, the higher the risk of injury.

To reduce these risks:

- A. Avoid roads with regular traffic, even if the speed limit is low.
 - B. Whenever possible, stay on roads and lanes limited to low speed vehicles.
 - C. Wear your safety belts at all times.
 - D. Avoid operating at night, because your vehicle may be hard for others to see.
 - E. Never drink and drive.
 - F. And, to help avoid rollovers, SLOW DOWN BEFORE MAKING SHARP TURNS.
- In addition, if this vehicle impedes traffic, the driver could be subject to a citation. (The top speed of this vehicle is about 21 mph.) This is all the more reason to avoid roads with regular traffic and never to operate on roads with speed limits above 25 mph.
 - We wish we had space here to provide all safety related information about Bentley vehicles, but we don’t. You’ll find more information in the Operator’s Manual which we encourage all users to read.
 - I also agree to adhere to the following additional terms:
 1. All incidents/crashes involving damage to this vehicle or injury to any person will be reported to, including reporting incident/crash to, Bentley University Police at 781-891-2201 and Bentley Facilities Work Order Control at 781-891-2208.
 2. No action(s) will be taken to alter the timing mechanism or otherwise change the top speed of the vehicle(s).
 3. No more than (2) occupants will ride on the vehicle(s) at a time. No one will ride in any part of the vehicle that is not equipped with a seat and safety belt.
 4. No occupant will hold a child on his or her lap while the vehicle is moving.
 5. No child under 12 years will be transported in the Bentley vehicle(s).
 6. Not to operate the vehicle on any golf course, since its top speed is too fast for safe use as a golf cart.
