

## **SUMMARY ANNUAL REPORT FOR BENTLEY UNIVERSITY FLEXIBLE HEALTHCARE BENEFIT PLAN**

This is a summary of the annual report of the BENTLEY UNIVERSITY FLEXIBLE HEALTHCARE BENEFIT PLAN (Employer Identification Number 04-1081650, Plan Number 514) for the plan year 01/01/2021 through 12/31/2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

### **Insurance Information**

The plan has insurance contracts with Lincoln National Life Insurance Company, Fidelity Security Life Insurance Company, Blue Cross Blue Shield Of Massachusetts, Inc., Harvard Pilgrim Health Care, Tufts Associated Health Maintenance Organization, Inc, HPHC Insurance Company, Metropolitan Life Insurance Company And Metropolitan Property And Casualty Insurance Co. to pay certain Long-term disability, Life insurance, Vision, Health, Retiree , HMO contract, PPO contract, Accident, Critical Illness, and Legal claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2021 were \$1,363,049.
