



Reunion Five-Year Pledge Initiative

Reunion 2020

What is it? This year marks a significant anniversary of your graduation from Bentley, and an opportunity to reminisce about your experiences as a student. It is also a time to reflect on how Bentley influenced and prepared you for your life and career, as well as what it means to be an alumnus/a.

As you prepare to celebrate your Bentley Reunion, please consider demonstrating your appreciation for Bentley — along with your belief in its importance for today’s students — by making a notable reunion gift. Your gift will be added to those of your classmates to total your Reunion Class Gift.

If you choose to make your gift at a President’s Club level, you have the opportunity to impact your Reunion Class Gift with a five-year pledge. **Your pledged amount for all five years will be counted toward your Reunion Class Gift**, while providing Bentley a steady stream of income that is used to enrich the experience of its students and attract talented faculty and future applicants.

What is the President’s Club? The President’s Club is Bentley’s leadership donor society that gratefully acknowledges donors whose gifts total \$1,000 or more during Bentley’s fiscal year with special correspondence and events throughout the year.

How does the Pledge Initiative work? Your gift must be at least \$1,000 each fiscal year. Giving smaller amounts monthly that equal \$1,000 is also an option and makes you a member of the President’s Club. Your gift to the Bentley Fund is inclusive of any matching gifts from your employer.

Example:

Fiscal Year 2021	\$1,000
Fiscal Year 2022	\$1,000
Fiscal Year 2023	\$1,000
Fiscal Year 2024	\$1,000
Your 2020 Reunion Class Gift	\$5,000

When are my payments due? Make one annual gift, or make monthly payments by dividing your President’s Club gift amount by the number of months remaining in the fiscal year, which ends on June 30.

When will I claim my contribution for tax purposes? Contributions are tax-deductible in the calendar year in which they are received.

Why should I consider a Five-Year Pledge? Your gift will help Bentley be sustainable, improve and grow. Your five-year pledge will have a greater impact on your class gift, and elevate your class’s presence in your reunion year. And, you will enjoy membership in Bentley’s leadership giving society, the President’s Club!
